New businesses are entering the market everyday, and existing businesses are looking to build an on-line presence. They want fast, easy, efficient ways to process credit card transactions on-line. As a Sales Partner, you will be able to offer these payment-processing services to your customers.

E-Commerce Services

Whether you are an ISP, web developer, designer, or shopping cart vendor you need a total e-commerce solution to succeed in this competitive environment. This includes the provision of a merchant account that allows your customers to accept credit card payments on-line, and the processing of these payments. The InternetSecure Sales Partner Program is designed to enable you to benefit financially by providing these services to your customers.

We are pleased to solidify the business alliance between your company (hereafter, the "Sales Partner") and Elavon Canada Company (hereafter, Elavon).

Elavon agrees to provide the following to Sales Partners:

- Commissions for Merchants referred to and accepted by Elavon for use of the InternetSecure service, as outlined below
- Processing of credit card and debit card transactions for approved Merchants at rates to be amended from time to time
- Visa, MasterCard, Amex, Discover and Interac Online Debit Merchant Accounts at competitive discount rates direct to your clients.
- Billing and collection of all applicable fees from the Merchant

As Sales Partner you agree to the following:

- The Sales Partner will provide its best efforts to promote InternetSecure services to current and prospective clients.
- The Sales Partner will not charge Elavon for any advertising to attract prospective merchant clients through banner ads or any other media, unless agreed in advance by Elavon. Elavon shall approve all copy prior to submission.
- The Sales Partner will not charge any additional fees for the "InternetSecure Services" and will not publish InternetSecure fees on their website, or in any other format without the express written consent of Elavon.

Revenue Sharing

Elavon shares the following revenues for each referred Merchant. Your monthly commission revenues will be determined based on all transactions generated by your referred merchant base.

Revenue sharing is at a rate of 20-30% based on the total number Merchants referred and accepted, and includes: Merchant Set-up fee (**one-time**), Monthly administrative fee (**recurring**), Transaction fees (**recurring**).

Term

We will pay commissions under this plan for 24 months from the date (month and year) in which Elavon accepts the merchant, as documented on your monthly commission statement.

Payments

Payment of the commissions will be made via cheque on or before the 15th day of the following month for all applicable merchant revenues in the previous month. For example: Commissions for your merchants' revenues in July will be paid by August 15th.

Type of Fees	When Paid
Merchant set-up fees (one-time)	Once approved as IS Merchant
Monthly administrative fees (recurring)	Once Merchant is billed
Transaction fees (recurring)	Once Merchant is processing transactions

Escalators

The monthly commission rate applicable will apply to **eligible merchant revenue streams** earned in the month for all Live merchants in your referral base. For example: if in the month of July you had 22 referred merchants, your commission rate would be 20%. If in the month of August, you had an additional 4 referrals (bringing your total to 26 referred merchants), your commission rate for all 26 merchants would increase to 25%.
